CNB FINANCIAL SERVICES, INC. ANNOUNCES RESULTS FOR THE QUARTER

Mark D. Harrell, President/CEO of CNB Financial Services, Inc. (CNB), the parent company of CNB Bank, Inc. announced for the three months ended March 31, 2022. CNB had consolidated net income of \$1.0 million, or \$2.57 per common share and \$2.83 per Class A common share as compared to \$942,000, or \$2.39 per common share and \$2.63 per Class A common share for the three months ended March 31, 2021.

Capital is a key measure of a bank's financial health and CNB continues to be rated a well capitalized financial institution by regulatory authorities. CNB's capital totaled \$36.6 million or 6.8% of total assets as of March 31, 2022.

CNB, with total assets at March 31, 2022 of \$539.1 million, has two full-service offices and ATMs in Berkeley Springs, West Virginia. The Bank has three full service branch offices and ATMs in Berkeley County, West Virginia.
